#### **GENERAL PROVISIONS**

The unit shall be a new current manufacturer's design and shall include all standard equipment unless otherwise specified.

The intent of the chassis is to be used under a hydraulically operated gravel body and hoist.

The truck cab and chassis shall be delivered to the gravel body supplier.

Dealer shall submit all warranty information with the truck bid.

One (1) complete service manual, one (1) complete parts manual and one (1) complete operator's manual shall be supplied with the unit.

The trade in unit also offered for direct sale, as-is, is a 1998 GMC 3.5 TON C7 CAB & CHASSIS WITH SPREADER BODY, Serial # 1GDL7H1M8WJ506277.

The bidder shall complete the specification checklist and submit it with the bid proposal, for each unit bid. The total bid price shall not include any federal excise tax or North Dakota sales tax and exemption certificates shall be furnished with the bid documents.
