

JAMESTOWN CITY COUNCIL
ORGANIZATIONAL MEETING, JUNE 24, 2014
OFFICIAL MINUTES

City Attorney Dalsted administered the oath of office to newly elected Mayor Katie Andersen and Council Member Ramone Gumke.

The organizational meeting of the City Council was called to order by Mayor Andersen at 4:30 P.M.

The Pledge of Allegiance to the flag was recited.

Roll Call showed the following members present: Mayor Andersen, Council Members Buchanan, Brubakken, Gumke and Kourajian, City Attorney Dalsted and City Administrator Fuchs.

Mayor Andersen nominated Council Member Gumke to serve as President of the Council. Seconded by Council Member Brubakken. Unanimous aye vote. Carried.

Mayor Andersen nominated Council Member Brubakken to serve as Vice-President of the Council. Seconded by Council Member Gumke. Unanimous aye vote. Carried.

Council Member Brubakken moved to appoint Ken Dalsted to serve as City Attorney and Assistant City Prosecutor for a two year term to expire June 2016. Seconded by Council Member Gumke. Unanimous aye vote. Carried.

Council Member Gumke moved to appoint Leo Ryan to serve as City Prosecutor and Assistant City Attorney for a two year term to expire June 2016. Seconded by Council Member Kourajian. Unanimous aye vote. Carried.

Council Member Gumke moved to appoint Mary Jensen and Kara Helgeson to serve as Assistant City Prosecutors/Assistant City Attorneys for two year terms to expire June 2016. Seconded by Council Member Brubakken. Unanimous aye vote. Carried.

Council Member Gumke moved to appoint Ashley Lies to serve as an Assistant City Attorney for a two year term to expire June 2016. Seconded by Council Member Brubakken. Unanimous aye vote. Carried.

Council Member Buchanan moved to appoint Travis Peterson to serve as a Special City Prosecutor for a two year term to expire June 2016. Seconded by Council Member Kourajian. Unanimous aye vote. Carried.

Council Member Brubakken moved to appoint Katie Andersen to serve on the Jamestown/Stutsman Development Corporation Board for a two year term to expire June 2016. Seconded by Council Member Gumke. Unanimous aye vote. Carried.

Mayor Andersen moved to appoint Council Member Buchanan to serve as a City Council representative on the County Zoning Board for a four year term to expire June 2018. Seconded by Council Member Gumke. Unanimous aye vote. Carried.

Mayor Andersen made the following appointments of Committee Chairs: Finance & Legal Committee (Council Member Brubakken); Building, Zoning and Planning Committee (Mayor Andersen); Civic Center & Promotion Committee (Council Member Buchanan); Police & Fire Committee (Council Member Kourajian); and Public Works Committee(Council Member Gumke).

Council Member Kourajian moved to adjourn. Seconded by Council Member Gumke. Unanimous aye vote. Carried.
