

SURVEYORS CERTIFICATE:

I, Donald Wenaas, a Registered Professional Engineer and Land Surveyor in the State of North Dakota, and as surveyor of the attached plat of BACK NINE SUBDIVISION, do declare and make known that said Plat is a part of the East Half (E 1/2) of the Northeast Quarter (NE 1/4) of Section Eight (8), Township One Hundred and Thirty Nine North (T139N) of Range Sixty Three West (R63W) in Stutsman County, North Dakota, and is more particularly described as follows:

The South 1583 feet of the E 1/2 of the NE 1/4 of Section 8, T139N, R63W, and still more particularly described as beginning at the Southeast corner of the NE 1/4 of said Section 8, hence N 89° 46' W along the South line of said NE 1/4 for a distance of 1313.7 feet, hence N 0° 04' W along the 1/4 line for a distance of 1583 feet, hence S 89° 46' E for a distance of 1305.4 feet to the East line of said NE 1/4, hence S 0° 22' E along said East line for a distance of 1583 feet to the point of beginning. Said parcel contains 17.6 acres, more or less, and is shown on the attached sketch.

I further certify that the attached plat of BACK NINE SUBDIVISION was made by me from an actual survey thereof and the same is correct and true to the best of my knowledge. The figures representing lengths, breadths, and distances denote feet and decimal fractions thereof. 


