Dunstan's Addition to Jamestown is situated in Stutsman County, Dak. Ter. on the west 1/2 of the N.W. 1/4 of Sec 31, T. 140, R. 63, and is further located as follows. Beginning at the N.W. cor. of said Section 31. Thence S 00° 15' W. 1530 ft. Thence S 89° 41' E. 1097.5 ft. Thence N 00° 15' E. 1523 ft. Thence N 89° 31' W. 1097.5 ft. to place of beginning. All full lots are 50 x 140 feet. Pacific Ave is 50 ft wide, Superior Ave. 33 ft. Dakota Ave 40 feet. All other avenues are 80 ft wide. All Alleys are 20 ft wide. Stones to serve as monuments have been sunk in the earth at the section corner and at intersection of the East line of Superior Ave. with the South boundary of said Addition and their position noted on the plat thus "Monument". 
