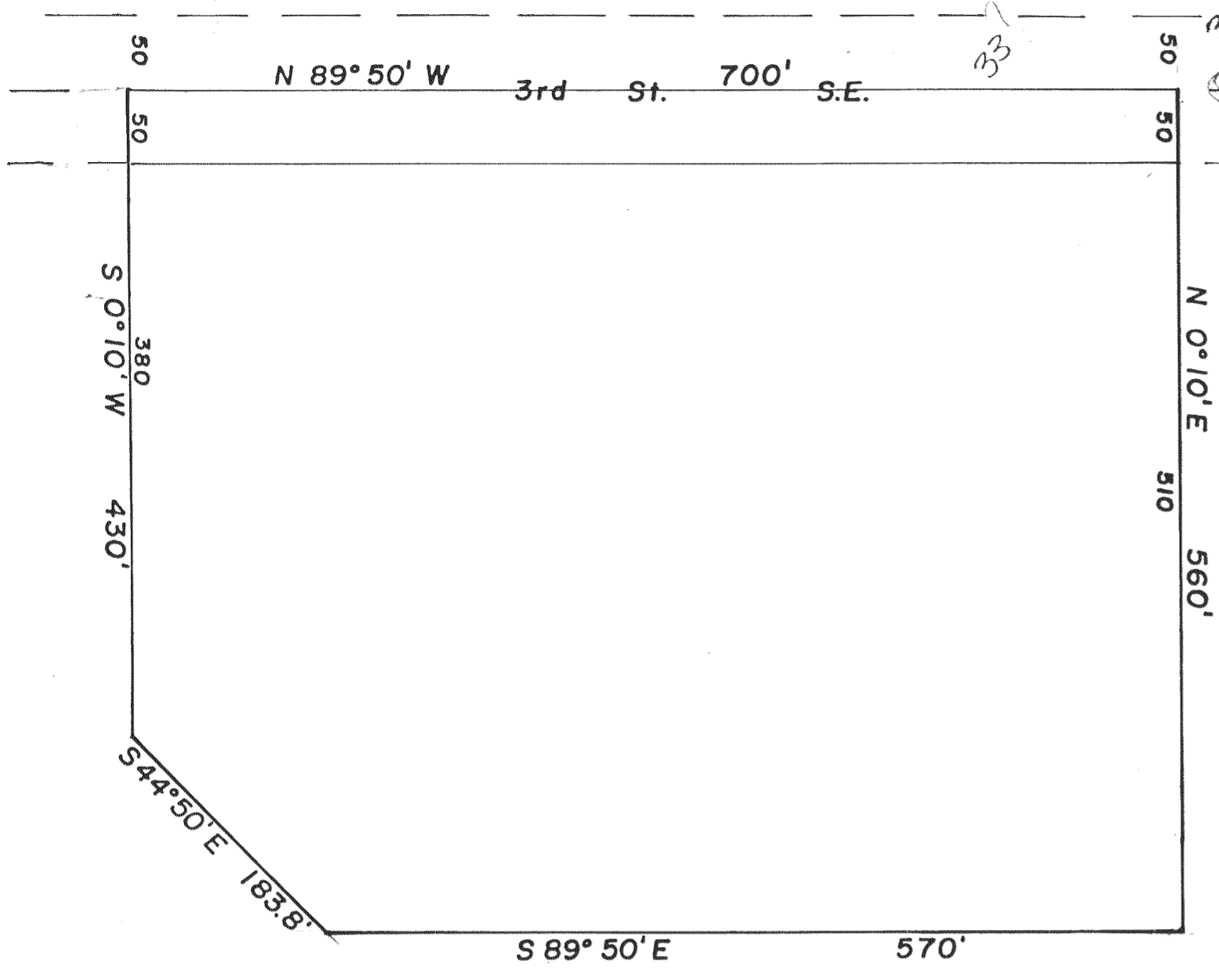

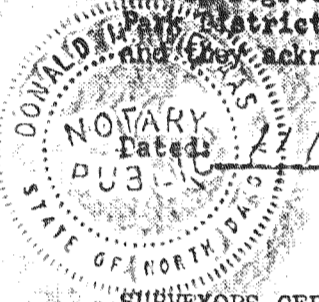

**SURVEYORS CERTIFICATE:**

I, Donald Wenaas, a Registered Professional Engineer and Land Surveyor in the State of North Dakota, and as surveyor of the attached plat of ELK'S HILLCREST ADDITION to the City of Jamestown, North Dakota do declare and make known that said plat is in the Northeast Quarter (NE 1/4) of Section Thirty One (31), Township One Hundred and Forty North (T140N), Range Sixty Three West (R63W), in Jamestown, Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at a point on the North line of the NE 1/4 of Section 31, T140N, R63W, said point being N 89° 50' W a distance of 1489 feet from the NE corner of said NE 1/4, hence from this point of beginning continuing N 89° 50' W along said section line for a distance of 700 feet, hence S 0° 10' W for a distance of 430 feet, hence S 44° 50' E for a distance of 183.8 feet, hence S 89° 50' E for a distance of 570 feet, hence N 0° 10' E for a distance of 560 feet to the point of beginning. Said parcel contains 8.8 acres, more or less, and is shown on the attached plat.

I further certify that this plat of ELK'S HILLCREST ADDITION to the City of Jamestown, North Dakota was made by me from an actual survey thereof and that it is correct and true to the best of my knowledge. The figures representing distances, lengths and breadths denote feet and decimal fractions thereof. 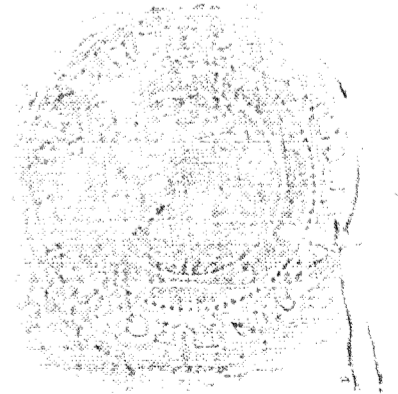
